## **CIRCULAR 14: BUILDING CONTROL OFFICES - REGION 03**

Further to the previous Circular (Circular 13) issued by the Division Built Environment and Enforcement in Economic Development and Spatial Planning Department (EDSP), the Department vacated the offices in the CBD (Isivuno Offices) on 15 December 2021.

The Department is in the process of relocating to the Middestad Building located at 252 Thabo Sehume Street, Pretoria.

The relocation affects the services rendered by staff members form City Planning & Development Division, the Built Environment & Enforcement Division (including the Region 3 Building Control Office) and the Management & Admin Support Section.

The logistics regarding the relocation is managed at a corporate level by Property Management and EDSP assists where we can.

We are aware of the challenges that our clients are facing as a result of the relocation and in the interest of customer service, alternative arrangements where possible, have been made to ensure continuation of business processes.

The aim was to occupy the building by 15 January 2022, however there are a number of matters that had to be attended to, such as that the building complies with the
