



26TH ANNUAL GENERAL MEETING

WELCOME

Mauneen welcomed all to the Annual General Meeting. Special mention was made of Jeremie Malan (PIA President), Ruben Reddie (SAIA President), Jacquie Cullis (Recently appointed acting EO of SAIA), Thomas Chapman (Guest Speaker), Weich Lippert (PIA Auditor), Louis van der Watt (Atterbury Properties), PIA Committee Members, Members of the PIA, other guests and staff of the PIA.

All in attendance were informed that the PIA Annual Financial Statements together with the PIA Annual Report was forwarded electronically to all members.

PRESIDENT'S ADDRESS – JEREMIE MALAN Jeremie addressed the members. The address is attached to the minutes as Annexure 1.

SHORT ADDRESS BY RUBEN REDDIE

Ruben introduced himself to the attendees and briefly discussed some pertinent SAIA frustrations and matters which caused administrative delivery issues for most part of the year. Ruben also briefly touched on general concerns within the industry and stressed the need for support of the SAIA and its regions and the importance of the Voluntary Associations for the profession. Mauneen thanked him for his time and addressing the members.

PRESENTATION BY THOMAS CHAPMAN

Thomas Chapman, an architect and urban designer based in Johannesburg, presented a very inspiring architectural presentation covering the work done by his practice, Local Studio. He offered to present more on similar projects in the new year. Thomas also spoke about his Book, Hustles, of which there are still some copies available.

Mauneen thanked him for an enlightening presentation and confirmed to contact him with regards the presentations. Mauneen will also obtain consignment stock of his publication, which will be available from the PIA Office in the new year.



PROCEDURES - DUE NOTICE AND QUORUM

There were 80 attendees present. In order for a quorum to be established, 24 voting members (1/20 of voting membership) were required to be present at the meeting. With 68 voting members, a quorum was established and the meeting could continue.

APOLOGIES FOR ABSENCE

Mauneen informed all regarding apologies which were received: Marinda Bolt, Pieter Mathews, Stan Segal and Erna Wiese forwarded their apologies for the meeting.

CONFIRMATION OF PREVIOUS MINUTES

Mauneen informed all that the Minutes of the previous AGM (included in the annual report and forwarded separately) were sent out to all the PIA members, together with the financials of the 2020/2021 fiscal. The acceptance of the minutes was proposed by Faan Nel and seconded by Mireille Bezuidenhout. The meeting approved and accepted the minutes.

FINALISATION OF AGENDA

The meeting accepted the agenda of the AGM. No further items were added to the proposed agenda.

FINANCIALS AUDITOR'S REPORTS

Auditor's Report

Weich Lippert presented the report for the 2020/2021 Fiscal. The report is also included in the Financial Report forwarded. He stated that there were no red flags and that the PIA, considering all the constraints, are in a healthy financial position.

Membership Fees and Budget

Mauneen informed all present that the PIA membership fees were increased by 5%. The Budget was sent out to the membership on 15 June 2021 and several times after. All were also informed that as the PIA managed to keep expenditure to a bare minimum, and the additional work which were required with a staff member short, the Executive decided to pay the staff back the 20% deducted off their salaries for 3 of the 6 months. Mauneen expressed her appreciation on behalf of herself and the other staff members

Approval of Budget

The approval of the budget was forwarded to all members on 15 June 2021. The PIA received 16 approvals and 0 dispute from the membership. Attendees were asked to offer any objections to the proposed budget which was sent out. No objections were raised.

Ben Burger approved the budget and Jean Grove seconded the budget.

The Presidents Report is included in the Annual Report. Attendees were encouraged to please read his report.

SUB COMMITTEE REPORTS

Mauneen asked members to please also read the respective reports as included in the Annual report sent out and contact the PIA offices for any queries or clarification on matters reported on. The reports give a very comprehensive overview on work done by the committees on behalf of the profession.

Len Verdoorn unfortunately had to resign from the PIA Committee. The PIA thanks him for his time serving the members and profession.

All committee members were thanked again for their time and service and wished well for the next year and term.

I also trust that the Covid-19 pandemic will be controlled in the coming year and that we can return to normal.

The PIA Executive has worked closely with our committee and the six portfolios to provide services in a consistent and professional manor.

Often, we are asked what does the PIA do for its members and the answers are mostly of administrative content and seemingly uninteresting but without the dedication to resolve matters as a group we won't be able to serve ourselves better as individuals. Our

functions and events with CPD points on offer are highlights which are all well received and attended.

Nonetheless the additional highlight during the year was our bi-annual Merit Awards Programme which provided high excitement and interest. We received high quality projects which were meaningful, resourceful and sustainable besides being beautiful. The entries will be exhibited at a venue to be determined and possibly at public facilities to maximize exposure for our entrants. There were 4 Awards of Excellence, 7 Merit Awards, and 15 Commendations for Architecture – well done to all that entered their projects and also congratulations to those receiving awards.

We trust that our events have contributed to our members' professional development. This year we had 34 events and 108 speakers which is truly a remarkable effort by our committee members and staff – thank you all. The year was packed with our usual events plus the highly successful IDEAS Conference and Merit Awards Programme.



Furthermore, our Practical Practice Programme courses are of the highest standard and will continue to be so with excellent programmes which will be lined up by Mauneen and her team in the new year. Thank you to Colin and the team for your most professional efforts.

We also trust that other functions and events in the coming year will be successful and held live again and look forward to the President's breakfast's, JAM Sessions and speakers' forums where prominent architects and designers can highlight their latest work and we will also plan visits to particular buildings, districts or towns of architectural interest. These would again include bus tours and wine evenings of which one such event was held during the past year where terroir, labels and wine glasses were also discussed.

We also continue to liaise with the City Council regarding the administration of SDP's, building plans and rezoning. The success of these deliberations lies in the positioning of our case for efficient liaison with Council and we continue to work for an electronic submission and tracking system and also for more architects at Council to deal with our complicated issues.

Nonetheless the past year has been the most challenging yet as their offices were closed or partially closed for a long time due to the lock down. The PIA represents our members at the Tshwane Public Development Forum where we use the opportunity to state architects' position regarding building plans, SDP's and development initiatives by the private sector. The PDF and Task Teams is an excellent platform initiated by

Council and the Capital City Business Chamber to address these issues.

We have had many heritage challenges during the past years and we continue to see the steady demise of historic suburbs such as Brooklyn, Arcadia, Clydesdale, Hatfield, CBD west and Marabastad. The historic suburbs seem to take the brunt of rezoning and in the long term we are all the poorer for it. Nonetheless the PIA will continue to support new development but have generally become an interested and affected party to provide a heritage insight. We have a heritage committee who has set a course to provide electronic documentation and a database of buildings in Tshwane considered to be of value. This is an undertaking in cooperation between the City Council and the UP -Department of Architecture under Prof. Arthur Barker and Jan Hugo who have commenced with this database - thank you.

We have sub-committees responsible for considering and / or liaising regarding transformation, practice matters, members benefits, education (TUKS and TUT), events and marketing. These committees put in sterling work and long hours to arrange, plan, execute and then start all over again. Too much to say and not enough time...

A special note of thanks to the Transformation Portfolio who have consistently placed this agenda on the table, Chair Nompilo Okyere-Dede, Jeremy Gibberd, Camilo Mogni and Claire McCusker. They have made the point that the youth need earlier access to the professional



environment and we will be focusing on this in the new year. We have already seen a growth in young architects joining the PIA during the past year. Nompilo and team have had two very successful events with the University of Pretoria Department of Architecture and Seat @ the Table Webinar which focused on the views and perceptions of a wide range of different ages, genders, races, political and architectural views. Both were very successful and energized the participants — thank you.

One of the duties of the President is to liaise with SACAP and SAIA. The PIA President is a board member of SAIA and also deliberates on the massive challenges the profession faces seeking solutions. This year has seen our CEO Mtembeni Mkhize pass away due to Covid-19 and a new Executive Officer has been appointed. SAIA has had major challenges in administration but we have a new President in Reuben Reddy and a new Vice President in Amira Osman who is also a PIA member — congratulations.

We also have a good working relationship with SACAP and trust this will continue in the new year with various challenges regarding a new MOU and fee schedules. We were concerned with a proposed new code of conduct from SACAP and after forwarding our concerns to them we were well heard – thank you to our Practice Portfolio and SACAP.

Our website has undergone major changes recently with a fresh new look and easy access. We are highly indebted to Mauneen, Marlize and Ishara who worked tirelessly with the tech company, Building Brands for a major success. Trust that all members are using the website to good effect.

The PIA undertakes to address all professional matters of our members in the best and most suitable manor given the context and possible outcomes. Don't hesitate to correspond with our secretariat on any matter you may deem to be of importance and mutual benefit. We can't resolve all matters but surely will try our best. We also urge you to grow the PIA by firstly paying subscription fees and encouraging other architects to join our membership circle. We presently have \pm 60% paid up and 18 new members for a net growth rate in membership for the year and we are now 563 members.



These sub-committees have had a jam-packed agenda with a wide range of subjects to cover all our members broad interests and then also specialized focus areas. These initiatives are well managed and coordinated by the PIA with endless arranging of meetings and speakers – no mean task which is always well attended with positive feedbacks. Once again, a huge thank you to our staff and committee members.

We also had our bi-annual Awards presentation during 2021 and many excellent buildings were highlighted for merit, excellence and commendations. A huge thank you to all involved including convenor Karlien, her adjudication panel and the general management by Mauneen and staff – truly another memorable event.

Our PIA family continues to thrive under these pressure cooker circumstances with intense management procedures – please forward your particular subject and proposals to consider and arrange in future as it takes time to find speakers and arrange the events.

Of particular interest to myself has been the Council liaison journey, which has had up and down



emotions. Liaison has been hampered by the lockdown regulations with officials not serving the public from Council offices but on-line. Many of you have endured massive backlogs (especially at region 3) due to the move to new offices, under staffing, no electronic systems, rezoning delays, archiving problems related to lack of shelving and many more.

Nonetheless we have had success with our Council liaison regarding an easier building plan administration process new region 3 offices, reduction of health plan fee, open communication lines to senior Council officials and the WhatsApp group liaison managed by Mauneen and COT officials. Thank you to COT officials who have assisted under difficult times and Mauneen's tireless efforts.

Meetings with the Council to discuss our concerns have been via the Task Teams, Public Development Forum and a meeting with the Mayor and MMC. Our concerns have and continue to receive attention. The Council have reported that the long-awaited electronic submission and tracking system is receiving serious attention with solutions awaited shortly. We have had a small but effective PIA task team which coordinates and proposes solutions to the problems at Council – a big thank you to these members.

I have regularly written to members using the Presidents Pen as liaison and have on a monthly basis explained the inner workings of the PIA and how we serve members interests. In these circulars I have pointed out how our staff and individual committee members have provided their time and expertise for the broader benefit of our profession. I trust these communications served you well.

A very special thank you to the executive committee serving with me namely Vice-President Claire McCusker, Past President Isia Ortner and Executive Officer Mauneen van Wyk who have consistently served many hours over a very difficult period. Nonetheless the hard work has had many successful outcomes and in general the PIA has taken many steps forward as a region which was already on a very high level.

Nonetheless SAIA is now on a new footing with many of the challenges resolved and a new horizon awaits. With this in mind I end with a piece from the February 2022 issue of National Geographic written by Robert Kunzig on the restoration of the Notre Dame Cathedral in Paris – "Rebuilding an Icon – Ater the Fire:

"...... Villeneuve (restoration architect) owes his current mission, the fight of his professional life, to his ingenious predecessor, Viollet-le-Duc. He invented the restoration of historic monuments, Villeneuve said. "That didn't happen before. Before, people repaired them, and they repaired them in the style of their day. Or they didn't repair them, and tore them down".

In 19th century France, a government first established institutions to grapple systematically with a question that concerns us all: What part of the past is worth preserving and transmitting to posterity? What duty do we owe the creations of our ancestors, what strength and stability do we draw from their presence – and when, on the contrary, do they become a lead weight, preventing

us from projecting ourselves into the future, from creating a world of our own? The question is one each of us faces in microcosm, in our work and in our life. Each of us has a **service des monuments historiques** in our head, struggling to decide what to hold on to and what to toss, which change to resist and which to embrace.

We need to ask ourselves "......... what to hold on to and what to toss, which change to resist and which to embrace." and here I refer not only to our responsibility to architectural heritage but also to the way architects will practice, work and design in future.





4.1 .Report from the University of Pretoria (UP - Boukunde) 2021-2022 Report by Arthur Barker

After a 2-week mid-year break, semester two academic activities, in Boukunde, resumed in a partial online fashion on the 1st of August 2021. Most lectures were held online while some studio sessions were held on campus.

On the 8th of September, *cum laude* alumnus Jankel Niewoudt (MArch(Prof) 2011) presented a Boukuknde talk titled "what now? Conceptualising a career in architecture".

Four alumni associated with three architectural practices, Gawie Fagan in Cape Town, Andre Eksteen from Earthworld in Pretoria and Liani and Jan Douglas from Douglas and Company in Cape Town all won AfriSam-SAIA Sustainable Design Awards for their respective projects, namely the Hillside Clinic in Beaufort West, Future Africa Campus and House Douglas.

On the 20th of October, Fiona Dunin of the Australian based architectural practice FMD Architects presented a Boukunde school talk titled "Oscillations between the pragmatic and the poetic".

On the 19th of October the second instalment of Dutch South African architectural connections titled "Common Ground" was simultaneously launched in Amsterdam, Pretoria and Cape Town through a mini symposium at the Dutch Embassy in Pretoria (https://www.zuidafrikahuis.nl/product/nieuw-

ontdekte-nederlandse-architectuur-in-zuid-afrika/)

On the 17th of November a second Boukunde talk was presented by André Krige of 255 Architects with a title of "Polychromatic Architecture".

Final exams began on the 27th of November and, for the first time in two years, the M(Arch)Prof exams (13 to 15 December) were held in Boukunde. A first for the Department, was the use of the new digital crit venue with 8 larger-than-life high-resolution screens.



The top Boukunde MArch(Prof) student of 2021, Wian Jordaan, was announced as the regional winner of the 35th annual Corobrik Architecture at the Masters' Valediction that was held on the 15th of December. Wian received a prize of R10 000 and represented UP at the National Corobrik competition in 2022. Runners up were Cameron Forder and Ruan Ras while Wian Jordaan also won the R5000 prize for best use of brick. On the 24th of December the sad news of the passing of Alewyn Petrus Burger (30/10/1933 -23/12/2021) was received. Burger was Professor and Head of the Department of Architecture at the University of Pretoria from 1967-1985. Emeritus Professor, Roger Fisher, noted that the "death of Alewyn yesterday morning, after a short illness, brings to the close a life lived both privately and without wish for fanfare. It would, however, be remiss to forget, although he being absent from academia for some thirty-five years, the profound contributions he made both to the profession of Architecture and its teaching in South Africa are still present. He never sought the limelight and eschewed the glare of publicity, but in the Boukunde Building his ghost lingers, both as a rigorous implementer of standards for the curriculum and the physical manifestation of the building itself. The stature that the body of Architecture enjoys today as the vanguard of the profession is in no small part a tribute to his legacy. We regret the loss and extend condolences to his family, friends, colleagues and past students".

The 2022 academic year began on the 21st of February with lecture sessions online for the larger classes and in person lectures and studio sessions. The annual prize-giving ceremony in person was held on 17 May 2022. Due to COVID-19 restrictions only sponsors, prize-winners and staff were allowed in lecture hall 3-3 where the live event was held. The event was also live-streamed.

On the 18th of May, 125 Department of Architecture graduates were capped at Part 34 of the <u>University of Pretoria</u>'s <u>#AutumnGraduationCeremony</u>. One ex and one current Interior Architecture staff member received their PhD degrees.

Between the 23rd and the 26th of May the Department was visited by the South African Council for the Architectural Profession (SACAP) and The South African Council for the Landscape



Architectural Profession (SACLAP) for validation of academic programs. Following the successful unconditional validation of all programs in 2017, all current programs were again given unconditional validation until 2027.

On Saturday 4 June 2022, the Department invited prospective first-year architecture students, as well as their parents, quardians and friends, to attend Q+Arch Online, the annual virtual open day, where three sessions presented. were These focussed on specific programme clusters including the BSc Architecture Programme for beginner the Professional Postgraduate and students. Postgraduate Research Programmes in Architecture, Interior Architecture and Landscape Architecture.

On the 8th of June 2022, the Annual Corobrik Awards was, for the first time in two years, held in person, this time on the roof of the Radisson Red Hotel in Johannesburg. Wian Jordaan won a special prize for the best use of clay face brick in a project (https://www.studentawards.corobrik.co.za/).



Exams began on the 11th of June and will end on the 9th of July. The second semester will begin on the 25th of July.

4.2. Report from the Tshwane University of Technology by Mostert van Schoor





Department of Architecture and Industrial Design

The second semester 2021 started on 21 September with most of the first semester classes still online in a multi-modal teaching model. The year was extended for all Under Graduate and Post Graduate years to the end of January 2022.

The selection process for new students for 2022 took place on the 18th and 25th of September and the 2nd of October 2021. A total of 253 students went through the selection process and 65 new students for the BArch and 15 students for the BArch extended programmes were selected.

Final Masters Examination and Corobrik event took place on the 19th and 20th of January 2022. After the examination 25 Candidates were awarded a Master of Architecture (Professional): Structured.

The Department's Corobrik finalist was Dean Smuts, with the title for her dissertation: The design of a contemporary rites of passage tailoring facility for at-risk boys in the Pretoria CBD.

Abstract


Recent civil movements such as #MeToo and #MenEngage indicate 'unhealthy' men in society. By se(cure)ing atrick boys, a healthier society is secured. Boys lack clear warkers and role models on their journey to becoming men.

This project focuses on at-risk boys and emphasises the importance of a guided and tailored transition from boyhood to manhood. This project addresses the lack of institutional structures for at-risk boys and recommends a tailoring facility in the Pretoria CBD. Amold Van Gennep's irrites of passage theory and Victor Turner's theory on liminality are developed to present an architectural typology tailored to at-risk boys transitioning from boyhood to manhood.

The concepts of adaptive re-use and the art of tailoring are applied to Huis Potgieter, an abandoned and underutilised building on the Unisa Sunnyside Campus. An appropriate contemporary architectural response will be applied and developed using the concept of transition through the art of tailoring and the concept of passage.

This architectural intervention includes tailoring the architecture to tailor the ar-risk boy, which in turn will result in the tailored man. The objective of the proposed design is to provide a structural and functional facility that facilitates the rites of passage or transitioning process from boyhood to manhood by implementing the artisan methods of teaching the art of tailoring.





The tailored architecture and the incorporated -tailoring programmes will function as a rite of passage mechanism to transform, upskill, develop, support, heal, and later reintroduce the se(cured), tailored man, back into society.

Kirti Mistry won the prize for best use of bricks and the best student in Construction was Morné Pienaar.

The exams for all the years in the degree course were successfully completed in January 2022.

After a short brake registration of new first year BArch and BArch extended students started on the 10th of February 2022 with official classes for all year groups commencing on the 14th of February 2022.

Preparation for the accreditation board visit from the SACAP on the 15th to the 17th of August 2022 started early in the year.

ENVIRONMENTAL AFFAIRS – Jeremie Malan Portfolio Chair

The Environmental Matters Portfolio convenes with the President, Mauneen, Helene Potgieter, Dries Verbeek, Adriaan Louw, Arthur Barker, Mike van der Merwe and Len Verdoorn who decided to focus on two aspects namely Heritage matters and Council liaison. Liaison with Council has become intensive with various types of meetings being held.

The Public Development Forum (PDF) is a six-weekly meeting between Council employees, the NMC and the private sector consisting of consultants and developers. Various Task Teams have been set up for report back to the PDF and the PIA is represented by Isia, Dries, Mike and Mauneen on three of these i.e Building Plans, Open Space and Purchasing / Leasing of Council Land.

The Building Plans task team is time consuming and the engagement can at times be uncomfortable. Nonetheless, progress is being made with the various problematic areas and the Council has committed to going on-line for submissions and tracking of plans. Furthermore, our Task Teams are liaising to improve the 7/6 approval process (on-site approval prior to plan approval), new Metro Green Building By-laws and plan approval fee structures. We have objected to a new Health Department fee for issuing of an occupation certificate, which was thankfully revised by Council to a lower fee.

On the heritage front our sub-committee with Helene Potgieter as chair and Prof. Arthur Barker, Karlien Thomashoff, Jan Hugo and Adriaan Louw advising, commenting on, and objecting to various demolitions of especially old heritage suburbs.

The PIA regularly liaises with Council and private sector regarding heritage matters. We commit to intend improving liaison with our other regions and



Docomomo. Especially the Docomomo liaison has become important due to the 60-year demolition clause in the Act, as many modernist buildings are at the limit and are being demolished. Please read up about Docomomo and join the movement. Registrations are only allowed during December for the following year.

THE CITY OF TSHWANE: PROPERTY DEVELOPER'S FORUM

TASK TEAM SIX (TT6): Leasing & Purchasing of

Council Properties

The City of Tshwane Group Property Department has developed a comprehensive Immovable Property Asset Strategy to raise the municipality's level of management practices to encourage new developments, regenerate spatial integration and stimulate local economic development.

The Task Team comprise membership of both the private sector (property developers and property practitioners and related supportive professional service providers to the property development industry) identified within the Property Developer's Forum, who will deal with the interests of developments across the City with the understanding to optimize the assurance coverage to be obtained from Group Property Department on the areas affecting matters of developers as far



Council owned properties are concerned for processing on governance and risk management. This forum can assist the department translate the strategy into one of its programs of action.

The TT6 objectives:

- -Address outstanding matters and lessons and identify the need for review of existing policies or the development of new policies and principles.
- -Identify and resolve emerging bottlenecks which impact on the implementation of the outcome and which hamper effective service delivery to the property industry.
- -Ongoing monitoring of, and reporting on, implementation of the delivery agreement
- -Ensure appropriate and consistent reporting and communication to stakeholders, professional service providers and property developers on matters.
- -Efficient coverage and ultimately report on the outcome of work to the Property Developers Forum.
- -Where possible, particularly where the City is an owner of an asset affecting a development, take active steps to ensure the overall conditions are/ or become conducive to the creation of economic and social development opportunities.
- -Encourage dialogue on the departmental policies and principles by conveying recommendations to Council and the decision makers within the departments.
- -Become a monitoring mechanism of the municipality on the implementation of the economic development projects, policies and principles.
- -Become a monitoring mechanism of the municipality to report to the municipality through the



Developer's Forum any organized, large scale, unlawful property invasions of private or City property to investigate and take the necessary action.

- -To receive from Investment and Land Release Section properties that the Council wants to source, sell or lease and require the local authority to make land or property for sale or to let available on mandates to legal compliant property practitioners in order to market these properties in the marketplace at market values to greatest benefit for the City.
- 1. Very little interest was shown by Developers for City owned land identified for leasing.
- 2.A survey was proposed, focusing on how developers and practitioners can:
- -identify ahead of time, land of interest for the City to consider:
- -identify challenges that developers are experiencing when it comes to leasing properties and how it is handled.
- 3.A summary of the bid specifications for the development and lease of Council property was issued to the Task team on 11 February 2022 for comments.
- 4. The Survey to go out to a select Group first and then broaden it out. This is still in process. The PIA has been represented on Task Team 6 by Dries Verbeek and Mauneen van Wyk

The environmental committee of which I am a member, has had multiple engagements with CoT through the PDF, Task Teams and direct contact

with the Executive Mayor and MMC, to improve the desperate shortcomings in the SDP and Building Plan approval processes.

AGM 2022 Portfolio reports – Communications – City of Tshwane – Isia Ortner

The PIA has been active on the Property Developers' Forum (PDF) for a number of years. The Forum, which meets on average every 3 months, has been set up to enable communication between the City of Tshwane and various developers and professionals active in the City's development, with the aim of expediating growth. In addition to the Forum the City has set up Task Teams which meet on average every 6-8 weeks to deal with specific issues of concern. The PIA is currently on three of these Task Teams; TT4, which deals with matters pertaining to building plans; TT5, which deals with open spaces: and TT6, which deals with leasing and purchasing of council properties. The PIA has recently requested to revive the TT1 meetings to deal with SDP applications, but no feedback has been received so far.



Task Team 4 deals with Building Plan Approvals, with the aim of to bring to light problems experienced by our members in the course of Building Plan Applications, in obtaining approvals as well as Occupation Certificates. As to achievement of objectives in this regard, it is a work in progress to say the least, hampered by the City's lack of resources and fund to invest in additional posts and staff development, or even such basics as shelving for the archives.

The historically significant Nederduitch Hervormde Kerk van Afrika, du Toit Street, Pretoria CBD, is undergoing an adaptive re-use process to become a museum. The museum will form part of the South African Reserve Bank (SARB) campus. The planned museum will communicate the history, work, and responsibilities of the SARB. The SARB, as the new building custodian, is fully committed to the preservation of this iconic building through an adaptive re-use initiative.

The development will have a moderate impact on the historic fabric of the building and will contribute towards the historic significance of the building. The project is approached with great sensitivity and will preserve the history and character of the site. This is a rare and successful adaptive re-use from a church building (specific use building) to a museum (also a specific use building).

The church was built in the Dutch Renaissance Revival Style and the characteristic of this style is evident in the quartz shale bands and granite bands that wrap around the building. The Kirkness red face brick facades are laid in Flemish bond. The red face brick facades, with horizontal plinth bands, the steep corrugated sheeting roof with tower and roof ventilators lend a distinctly North European appearance to the building.

The building has a very strong connection to the Netherlands, having been designed, built, and




finished off by Dutch immigrants. The church cornerstone was laid by Gen Louis Botha in 1904. The sculptor Anton van Wouw completed wood carvings on the church, pulpit, and church pews. A memorial stone on the southeast corner is in commemoration of the Dutch nationals who fought and died in the Anglo Boer War (1899 – 1902). Cornelis van Gogh (brother of Vincent van Gogh) died in the Anglo Boer War and his name appears on the memorial stone.

The last church service was held on Sunday 13 May 2018, and the SARB purchase of the church building in 2018 included a provision that the church building would be conserved.


Restoration and Repair of the Pretoria City Hall

The City of Tshwane Metropolitan Municipality appointed a team of professionals to restore and repair the historic Pretoria City Hall and recommend new possible uses for the iconic building, which is currently standing empty.

In order to celebrate the city-status of Pretoria, city hall was built in 1931 and inaugurated in 1935. The building is located on Paul Kruger Street and across the street from the Natural History Museum (previously known as the Transvaal Museum). The domed central clock tower forms a well-known landmark in the CBD.

The organ, in the central concert hall, was built by WW Kimball Co (Opus 7134, 1935) with organ ID 30859, electro-pneumatic chests, 100 ranks and 5,923 pipes complete with 6 divisions, 4 manuals and 101 stops will receive special attention as part of the restoration process.

New EPC regulations for landlords - 2023

By December 2022 all public sector buildings larger than 1,000m² and all private sector buildings larger than 2,000m² are obliged to publicly display the respective buildings' Energy Performance Certificate (EPC's). The energy efficiency of a building will be displayed by using a colour-coded score ranging from A-G, similar to energy ratings found on electrical appliances.

This information will empower potential buyers and tenants to make informed decisions. The first step toward lowering energy consumption is having insight into energy consumption.

Certain information must be gathered and compiled to obtain an EPC: Electricity consumption for a year, the net floor area, information on areas excluded as well as vacancy rates, after which a SANAS accredited inspection body (IB) will audit the information.

GBSA Academy developed an interactive series of workshops focused on providing information on EPC's.

And EPC will provide a snapshot of any building's annual operational energy performance by means of measuring the energy consumption per meter². Background

The PIA Transformation Committee was formed in October 2018 and has since expended huge effort to get to grips with identifying transformation markers, supported by factual data, to identify the focus required for delivering a workable strategy for finding solutions and tactics for implementation.

The "Architect as Apprentice" was proposed as a workable solution to breaching inequality to access of affordable and high-quality education in architecture. A social compact made between the architectural industry, the CBE, Government and Universities, Regional Institutes of Architecture, and prospective students to create synergy to uplift the entire architectural community and result in a higher quality-built environment. The proposal was introduced to the public and various institutions during 2019 reaching a relative level of acceptance with the CBE, and SAIA but unfortunately some

reservations from SACAP and higher education institutions.

The PIA transformation committee has since nominated new members to be part of the committee. On the 26th January 2021 the following members were nominated; Nompilo Okyere-Dede (transformation chairlady), Claire McCusker, Jeremy Gibberd and Camilo Mogni. The committee set to align itself with the transformation strategic objectives from SAIA and SACAP in order to develop its own terms of reference going forward (see attached annexure). The terms of reference developed look at addressing transformation through two strategic ways, firstly, transforming taking profession (inward) this means introspective view of the organisation itself and finding ways to be more accessible and inclusive. Secondly, transforming the wider society and built environment (outward) through developing and sharing constructive commentary on built initiatives environment considered or being undertaken by the public and private sector.

Inward transformation

It is important for the institution to introspect and analyse itself in terms of the progress made in transforming and the reasons thereof and work on ways to improve itself. This involves reviewing some of its own policies and making the necessary changes to facilitate transformation within the organisation. To do this, the committee has discussed some document and policies that need to be reviewed, as well as some initiates to find out from its members what they think the issues are?

Documents to be reviewed:

- Reviewing the PIA constitution (Ongoing)
- Reviewing the criteria for evaluation of the PIA awards
- Student membership criteria
- PIA fees

Outward Transformation

The committee plans to support transformation in the wider society and built environments through providing high-level strategic built environment guidance, commentary, and support to key decision-makers in the public and private sector. As well as making available part-time or on ad-hoc basis expertise that can be drawn on to improve the effectiveness and efficiency of government infrastructure delivery programmes.

SACAP Report by Isia Ortner

The past year has been a busy and productive one in terms of the PIA communication with the City of Tshwane. Collaboration with SACAP has had some measure of success in the previous year, but the current year saw a marked decrease in forums, partly due to objectives achieved.

SACAP Benchmark Survey

SACAP has distributed the Benchmark survey to be filled out by all SACAP-registered practices in November 2021. The survey has closed only recently, on 20 July 2022, and so far no word has been received on the level of response or any of the results.

Guideline Professional Fees

The latest and updated fee scale was published by SACAP 15 July 2022, almost two years since the last publication. This represents a significant

improvement on the track record of the past, although still falling short of the requirements of the Act, which calls for updated Guideline Professional Fees to be published annually.

Identification of Work (IDoW), Limited Special Dispensation (LSD) and Recognition of Prior Learning (RPL)

The was published by SACAP on 30 April 2021 and no further editions have been submitted for comment. Many of the previously issued PIA comments have not been incorporated into this publication, so we are looking forward to the next edition where these can, hopefully, be addressed.

Limited Special Dispensation is a vehicle for those practices with projects that fall outside their scope as per the IDoW. SACAP presented a workshop Limited Special Dispensation application process on 22 July 2022. The recording is available on their Facebook page:

FINANCIAL STANDING

The current financial position of the PIA is healthy, but still not nearly where we were or could be. Our 1st priority should be to **increase our membership and build up our business affiliate support**. This is something which each and every member can assist with. Encourage all architectural professionals to join the membership and your suppliers to get involved. Having only one member per practice is just not enough, we need all of you on board to have the voice to be reconned with. After all – the work done by the PIA benefits everyone.

During the 2020 – 2021 year the PIA were 115 members less and this year we are a mere 8 members more, which means that we still have a lot of catching up to do. In total 40 members resigned/relocated or did not renew their membership and the sad passing of 5 members. Fortunately, 51 new members joined the PIA.

The PIA has kept the cost of workshops to the original amount since 2007 of approximately R100 per 0.1 CPD Credit as much as we are able to master this and often even less. Exception comes when

there are set tariffs which need to be paid to presenters of some workshops.

FUTURE

The PIA is only as strong as its membership and inputs as well as participation of all the members are needed to make the voice of the profession stronger. The PIA is its membership and your contribution makes the difference you want to see.

It is important to remember that even though financial strain is real to all, the PIA committee and staff are daily fighting on behalf of the profession. Very few really understand the vast impact we have on ensuring that you, as an architectural professional, remain relevant. Now imagine there is nobody to fight this fight on your behalf.

We need our business affiliates back on board aw without their support, unfortunately, it could mean that the PIA and other VAs are no longer able to substitute the members' portions of the attendance fees and we will be forced to increase the attendance fees at our workshops and functions.
